Luke's antitrust practice spans both sides of the docket. On the plaintiff side, he has argued Sherman Act monopolization appeals, litigated group boycott and conspiracy-to-monopolize claims, and represented clients facing exclusionary conduct by dominant firms and monopsonists. On the defense side, he has defended clients against class action antitrust claims in class action and multi-district litigation and complex commercial matters.

Luke has significant federal and state appellate experience, having briefed and argued matters before the Second, Fourth, Fifth, Eighth, Ninth, and Tenth Circuits, as well as the California and Minnesota Courts of Appeal.

Before entering private practice, Luke clerked for three federal judges: Judge Kermit E. Bye of the U.S. Court of Appeals for the Eighth Circuit, Judge Manuel L. Real of the Central District of California, and Judge Robert G. James of the Western District of Louisiana. He brings that judicial perspective to every matter — with a disciplined focus on the facts and legal issues that actually move the needle, from the earliest stages of litigation.

Prior to joining Bona Law, Luke practiced at Kanner & Whiteley in New Orleans and Robins Kaplan in Minneapolis.

Representative Matters

- Argued *Chase Manufacturing v. Johns Manville Corp.*, 84 F.4th 1157 (10th Cir. 2023), a Sherman Act Section 2 monopolization case against a near-100% market monopolist, in which the Tenth Circuit reversed summary judgment for the client.
- Argued *Drabinsky v. Actors' Equity Association*, 106 F.4th 206 (2d Cir. 2024), presenting a novel first-impression question on the scope of the statutory labor exemption to the Sherman Act and whether it constitutes an affirmative defense — a case in which the Second Circuit resolved a circuit split, with the AFL-CIO as amicus.
- Argued *Western Star Hospital Authority, Inc. v. City of Richmond*, 986 F.3d 354 (4th Cir. 2021), a Sherman Act Section 2 case challenging a municipal monopoly over the non-emergency ambulance market, presenting questions on the scope of state action immunity under the *Parker* doctrine.
- Defended a Japanese capacitor manufacturer against class action Sherman Act claims in federal multi-district litigation (*In re Capacitors Antitrust Litigation*).
- Counsel in *PharmacyChecker.com v. NABP et al.*, an antitrust case against pharmaceutical associations for conspiring to eliminate online pharmacy competition.
- Represented a nutrition supplement company in federal litigation involving Lanham Act false advertising claims (*Ariix, LLC v. NutriSearch Corp.*).
- Represented a data analytics company in group boycott and conspiracy-to-monopolize claims in the District of Colorado.
- Litigated antitrust claims against a major wireless carrier on behalf of a spectrum technology company, involving allegations of monopsony power and exclusionary conduct. (*T-Mobile v. WCO Spectrum*)
- Counsel for a defendant in *In re Turkey Antitrust Litigation*, a nationwide price-fixing class action MDL involving the turkey processing industry.
- Served as outside litigation counsel for the California Attorney General in *People v. Vitol*, a price-fixing case against global gasoline trading firms.
- Served as outside litigation counsel for the Louisiana Attorney General in healthcare and pharmaceutical litigation.
- Represented insurers in affirmative fraud and civil RICO litigation involving overbilling by hospital and laboratory defendants.
- Represented insurers in a national civil RICO class action involving pharmaceutical manufacturers of testosterone replacement therapy products.
- Represented clients in a national antitrust consumer class action involving pharmaceutical manufacturers of Adderall XR.
- Represented a class of consumers in set-top box antitrust litigation.
